ARTICLES OF INCORPORATION

We, the undersigned, hereby associate ourselves together in order to create, form, establish, and organize a corporation for profit under the General Corporation Code of the State of Kansas, and acts amendatory thereof, and supplemental thereto.

I. The name of this corporation is Burr-Hancock, Inc.

II. The location of its registered office in this state is No. 612-14 Second Avenue, Dodge City, Kansas.

III. The name and address of its resident agent in this state is Hiram T. Burr, No. 612 Second Avenue, Dodge City, Kansas.

IV. This corporation is organized for profit and the nature of the business and objects and purposes to be transacted, promoted and carried on, are as follows:

To hold, purchase, sell, convey, lease, mortgage, and dispose of real and personal property, and every legal interest therein.

To borrow money, and issue, sell, and pledge bonds, promissory notes, bills of exchange, debentures, and other obligations and evidences of indebtedness, secured or unsecured, and to purchase, hold, and dispose of the shares, bonds, and other evidences of indebtedness of other corporations, domestic or foreign, and of governmental subdivisions.

To loan money on property, real or personal, tangible or intangible,

To act as a general or special agent for insurance companies, domestic or foreign,

To act as agent for buyers or sellers of real and personal property, and to do and perform such other acts and things as may be necessary and proper to transact, promote, and carry on such business.

V. This corporation is authorized to issue only one class of stock, the total number of shares into which the stock shall be divided is Five Hundred (500) shares of the par value of One Hundred Dollars (\$100.00) per share.

VI. The amount of capital, including surplus, with which this corporation will commence business is Sixty Thousand Dollars (\$60,000.00).

VII. The incorporators and their places of residence are as follows:

VIII. The time for which this corporation shall exist is fifty years.

IX. The number of Directors of this corporation shall be Six (6).

X. The private property of stockholders in this corporation shall not be subject to the payment of debts of the corporation.

XI. No stockholder shall sell his stock, or any part thereof, to any person not already a stockholder in the corporation, unless the proposed seller first shall give to the corporation or other stockholders an opportunity to purchase the same.

XII. The stockholders shall, at the earliest practicable date, formulate by-laws to provide for the details of organization, administration, and business routine.


